2024 ALL THAILAND GOLF TOUR ANNUAL QUALIFYING SCHOOL

Closing Date for Applications 16 October 2023 (4:00 PM, Thailand time)

1. INTRODUCTION

Applicants can participate in the annual All Thailand Golf Tour (ATGT) Qualifying School ("Q-School") to qualify for a Member Exemption in the upcoming 2024 season. The leading 40 players and ties at the Final Qualifying Stage shall be entitled to ATGT Member Exemption Category 15 and shall join the leaders on the previous year's Order of Merit and certain other exempt players as ATGT members. The 2024 ATGT Member Exemption Categories list is noted in Appendix 1 (see pages 8-9).

Applicants shall be allocated spots on a "first come, first serve" basis, subject to availability. (Applicants cannot select the tournament day) The ATGT expects a very competitive Q-School that will run in the following two stages:

First Qualifying Stage (Section B)* - The Tournament committee may consider adding a round of competition when the number of applicants reaches the specified amount of the First Qualifying Stage (Section A). Subsequent applicants will compete in the first qualifying round (Section B), and the names of those who will compete in the first qualifying round (Section B) will be announced on October 20, 2023.

2. QUALIFYING SCHOOL FORMAT

First Qualifying Stage (Section A):

Dates: 7-10 November 2023. Practice Round: 6 November 2023

Player Registration: 5 November 2023; 7:00 AM – 4:00 PM (Thailand Time)

6 November 2023; 7:00 AM – 12:00 PM (Thailand Time)

First Qualifying Stage (Section B)*:

Dates: 14-17 November 2023. Practice Round: 13 November 2023

Player Registration: 12 November 2023; 7:00 AM – 4:00 PM (Thailand Time)

13 November 2023; 7:00 AM – 12:00 PM (Thailand Time)

Applicants shall compete in the First Qualifying Stage over four rounds or 72 holes. A field of approximately 120 players shall play two rounds. After 36 holes, the field shall be cut to the leading 80 and ties, who shall then play a further two rounds. If the starting field is less than 100 applicants, the field shall be cut to two-

thirds of the starting field. The number of players that can move to the Final Qualifying Stage shall be announced before the first round of the First Qualifying Stage tournament.

Players with tied scores for the final placement into the First Qualifying Stage shall proceed to the Final Qualifying Stage.

Every effort shall be made to complete four rounds, but a result can be declared if only three rounds are completed. Specifically, ATGT will cancel the final round scores if applicants cannot complete four rounds (72 holes) of the First Qualifying Stage, regardless of the number of holes remaining. ATGT will use the results of 54 holes to decide who will compete in the Final Qualifying Stage. If the First Qualifying Stage cannot conclude with the 54-hole Tournament results, ATGT will extend the competition to achieve a 54-hole result.

If a situation prevents the competition date from being extended further, Tournament results will be at the discretion of the Tournament committee.

Applicants who meet the following eligibility criteria for the Final Qualifying Stage and applicants who qualify from the First Qualifying Stage shall compete in the Final Qualifying Stage, which is played over four rounds (72 holes).

The following players are exempt from the First Stage and automatically eligible to participate in the Final Stage.

- a. Those who had exempted status in 2023 (top sixty (60) of the ATGT 2022 Final Order of Merit) but did not finish in the top sixty (60) of the ATGT 2023 Final Order of Merit and lost their exempted status for 2024 (*).
- b. The ATGT Order of Merit winners from 1999 who are not otherwise exempt.
- c. The ATGT members in positions sixty-first (61st) to one-hundred-twenty (120th) on the ATGT 2023 Final Order of Merit (*).
- d. The ATGT tournament winners from 1999 2021 who are not otherwise exempt.
- e. The leading five (5) players not otherwise exempt and within the top 125 from the 2023 US PGA Tour Order of Merit (**).
- f. The leading five (5) players not otherwise exempt and within the top 100 from the 2023 DP World Tour Order of Merit (**).
- g. The leading five (5) players not otherwise exempt and within the top 75 from the 2023 Japan Golf Tour Organization Order of Merit (**).
- h. The leading five (5) players not otherwise exempt and within the top 60 on the 2023 Asian Tour Order of Merit (**).
- i. The leading three (3) players not otherwise exempt and within the top 30 on the 2023 PGA Tour of Australasia Order of Merit (**).
- j. The leading three (3) players not otherwise exempt and within the top 30 on the 2023 Sunshine Tour Order of Merit (**).
- k. The leading five (5) players not otherwise exempt and within the top 50 on the 2023 Thailand PGA Tour Order of Merit (**).
- I. The leading three (3) players not otherwise exempt and within the top 30 on the 2023 PGT Asia Tour Order of Merit (**).

- m. The leading three (3) players not otherwise exempt and within the top 30 on the 2023 Taiwan PGA Tour Order of Merit (**).
- n. Nominations by the Tournament Committee at their discretion.

- o. The leading three (3) entrants to a limit of 30th place in the World Amateur Golf Ranking (**).
- p. Individual current winners of the following amateur events: a) Eisenhower Cup, b) Nomura Cup, c) Asian Games, d) SEA Games, e) Putra Cup, f) Asia Pacific Amateur Championship and g) Faldo Series Asia Grand Final.
- q. The leading five (5) players not otherwise exempt and within the top 20 on the 2023 Thailand Golf Association amateur ranking (Central Organization SB Class) (**)
- r. The leading five (5) players not otherwise exempt and within the top 10 on the 2023 ATGT Amateur Ranking Points.

(*) If the applicant is subsequently eligible to compete in 2024, the Tournament Committee will cancel the applicant's qualifying round application and refund all application fees.

(**) As of 16 October 2023.

Applicants shall compete in the Final Qualifying Stage over four rounds or 72 holes. A maximum field of 156 applicants shall play two rounds. After 36 holes, the field shall be cut to the leading 80 applicants and ties, who shall then play a further two rounds. After 72 holes, the top 40 and ties shall be awarded tour cards for

All tied scores shall be ranked by a Scorecard Count-Back as follows: The best aggregate score on the last (a) 36 holes, (b) 18 holes, (c) 9 holes, (d) 6 holes, and (e) 3 holes.

If there is still a tie, scores from the 18th hole of the final round shall be counted backward. Scorecard Count-Back will decide players with tied scorecards.

Every effort shall be made to complete four rounds, but a result can be declared if only three rounds are completed. Specifically, ATGT will cancel the final round scores if applicants cannot complete four rounds (72 holes) of the Final Qualifying Stage, regardless of the number of holes remaining. If the Final Qualifying Stage cannot conclude with the 54-hole Tournament results, ATGT will extend the competition to achieve a 54-hole result.

If a situation prevents the competition date from being extended further, Tournament results will be at the discretion of the Tournament committee.

3. APPLICATION FEE

Application fee – TH\$15,000, which covers entry for both stages. This entry fee does not include the Membership Fee for those admitted to the membership for 2024 and subsequent years (see Clause 9 (C)). Members can pay it through the ATGT Player Portal only.

4. ELIGIBILITY FOR APPLICANTS

All applicants who meet the below conditions are eligible to enter the Q-School:

- (A) Golfers who are 13 years of age or older, provided the applicant turns 14 years of age before the first round of the tournament week of any tournament of the ATGT in the 2024 season or according to the discretion of the tournament committee.
- (B) Male professional golfers.

(C) Male amateur golfers with a handicap of 5 or less under the handicapping scheme adopted by the recognized authority controlling golf in the country from which they elect to enter. A valid handicap certificate must accompany all applications.

NOTICE TO AMATEURS: It is not in itself a breach of the Rules of Amateur Status for an amateur golfer under the jurisdiction of R & A Rules Ltd to file an entry for and play in any stage of the Q-School, provided that the player waives his right to prize money before each Stage by completing the appropriate forms available onsite at each venue.

However, if an amateur participates in the Q-School for the first time as a professional and is unsuccessful, he may wish to apply for reinstatement as an amateur. Such an application for reinstatement may receive sympathetic consideration by the governing body of amateur golfers in such golfer's home country, and the amateur may be reinstated three months after the infringement of the Rules, provided participation in the Q-School is the amateur's only breach of the Rules of Amateur Status (Decision 9-2b/3)

5. NEW MEMBER SEMINAR

New member seminar attendance is <u>MANDATORY</u> for all players who made the cut after 36 holes from the Final Qualifying Stage. ATGT tournament committee will discuss rules and regulations, commitment protocols, membership matters, etc.

Seminar schedule: Section 1: Thursday, 28 December, 2023, after play.

Section 2: Friday, 29 December 2023, after play.

Note: ATGT reserves the right to alter or change the start time and duration of all seminar sessions for new members at the tournament committee's discretion. Please plan your departure schedule accordingly.

6. WITHDRAWALS & REFUNDS

The closing date for withdrawal is 23 October 2023 (4:00 PM, Thailand time)

- (A) If the applicant wishes to withdraw before the withdrawal deadline, He must only withdraw via the ATGT Player Portal system.
- (B) If withdrawal after the withdrawal deadline, the withdrawal must be in writing via email to <u>q-school2024@allthailandgolftour.com</u>
- (C) Conditions for a refund of application fee in case of withdrawal
 - I. If the applicant withdraws before the withdrawal deadline, the applicant will receive a refund of TH\$13,500 for the application fee (excluding domestic wire transfer fees or overseas wire transfer fees).
 - II. If the applicant withdraws after the closing date for health reasons with a medical certificate or reasonable reasons at the discretion of the Tournament Committee, applicants will receive a refund of 12,000 Baht.
 - III. If the applicant withdraws after the closing date without a reasonable reason, applicants will receive a refund of 7,500 Baht.
 - IV. If the applicant does not show up at the tee-off at the designated tournament time without notifying the staff in advance, applicants will not receive a refund of the application fee.
 - V. If the applicant has already started the competition, ATGT will not refund the application fee.
 - VI. Golfers who apply for the 2024 ATGT Q-School before the announcement of the Final 2023 Order of Merit (after the 24th Singha Thailand Masters) and earn the 2023 Order of Merit of No. 1-80 may withdraw from the 2024 ATGT Q-School registration and will receive a full refund of the application fee.

VII. If amateur golfers cannot provide a handicap certificate upon request, have a handicap exceeding 5, or do not meet the criteria, the application will be denied and will receive a refund of 13,500 baht for the application fee.

7. HOW TO APPLY

- 1) You can apply via online application at https://bit.ly/2024-atgt-qschool-form
- 2) After submitted the application, a response email from ATGT Player Portal will be sent to you within 48 Hours
- 3) Enter the ATGT Player Portal, create account and password
- 4) Go to Transaction menu to pay the application fee
- 5) Once your payment has been verified. You will receive another confirmation payment email, then your submission will be considered complete.

8. NOTIFICATION OF ACCEPTANCE OF APPLICATION / QUALIFYING DATE AND/OR VENUE

The registration is complete when the applicant pays for the competition via the ATGT Player Portal and receives a confirmation email.

If any additional venue is added to the schedule, the ATGT reserves the right to allocate applicants to any available date and/or venue.

9. GENERAL POLICIES

- (A) The ATGT reserves the right to change or amend the above format, conditions, and play schedule and reject application forms at any time. Conduct unbecoming of a professional or non-competitive performance records can be a basis for the rejection of applications.
- (B) The undersigned hereby applies to enter the 2024 ATGT Q-School only. Although membership in the ATGT is based principally on this competition, the ATGT reserves the right to enforce other reasonable criteria (including, but not limited to, character, conduct, financial responsibility, etc.) to all applicants for membership. The ATGT, in its sole discretion, shall determine whether to accept any membership application without assigning any reason for its decision.
- (C) Membership Fee: Regular Members of the ATGT, including newly admitted members, shall pay a membership fee of TH\$3,500 every year before the season-opening tournament, or TH\$2,500 for players ranked in Category 18-23 pay before their first tournament.
- (D) Insurances: Every applicant must have a valid Personal Accident insurance policy covering death and permanent disability caused by accidents. Every applicant is further advised to obtain Personal Liability insurance covering any negligent liability to any third party or claim arising from his participation in any tournament or competition in a minimum amount of Baht1 million.
- (E) Indemnification: The applicant undertakes to indemnify and hold harmless the ATGT from and against all liabilities, claims, costs, expenses, damages, and losses caused by any breach of rules, negligence, willful misconduct, or unlawful act by the applicant.
- (F) Exclusion of Liability: The applicant understands the risks inherent in playing golf and agrees that he shall not hold the ATGT liable for any death, bodily injuries, or property damage that he may suffer during participation in the Q-School.

10. SPECIFICATION OF CLUBS AND THE BALL

(A) List of Conforming Driver Heads.

Model Local Rule G-1 is in effect.

Penalty for making a stroke with a club in breach of this Local Rule: Disqualification.

(B) Groove and Punch Mark Specifications.

Model Local Rule G-2 is in effect.

Penalty for making a stroke with a club in breach of this Local Rule: Disqualification.

(C) List of Conforming Balls.

Model Local Rule G-3 is in effect.

Penalty for breach of this Local Rule: Disqualification.

(D) One Ball Rule.

Model Local Rule G-4 is in effect.

Penalty for making a stroke at a ball in breach of this Local Rule: One stroke penalty for each hole during which they are in breach of this local rule.

If a player discovers they have played a ball in breach of this local rule, they must revert to using a ball of the same brand and model as used at the start of the round when they play from the next teeing area, otherwise the player is disqualified.

(E) Replacing of Club that is Broken or Significantly Damaged.

Model Local Rule G-9.

"Rule 4.1a(2) is modified in this way:

Rule 4.1a(2) applies except that a club that is damaged by the player or their caddie during the round (including while play is stopped under Rule 5.7a) may only be replaced if it is "broken or significantly damaged"

A club is "broken or significantly damaged" when:

- The shaft breaks into pieces, splinters or is bent (but not when the shaft is only dented)
- The club face impact area is visibly deformed (but not when the club face is only scratched or cracked)
- The clubhead is visibly and significantly deformed (but not when the clubhead is only cracked)
- The clubhead is detached or loose from the shaft, or
- The grip is loose.
- (F) 46-inches Club Length Limitation.

Model Local Rule G-10 is in effect.

Penalty for making a stroke with a club in breach of this Local Rule: Disqualification.

11. QUALIFYING SCHOOL NOTES

- (a) Conduct Unbecoming of a Professional: Applicants must conduct themselves professionally.
- **(b) Personal Appearance:** Applicants must, at all times, present a neat appearance in clothing and personal grooming, as determined by the ATGT, while carrying out their duties as a professional at a golf course or a tournament function.

Shorts are allowed for practice rounds **only**. All shorts should be knee-length, tailored shorts and predominantly of one color. 'Cargo Pocket Styled' are **not** permitted. An applicant cannot wear denim jeans and t-shirts for practice or tournament rounds. In addition, an applicant must always adhere to golf club dress codes and clubhouse policies in effect.

- (c) Media Profile Form: All applicants competing in the Final Qualifying Stage should complete this in full.
- (d) Photography session: Golfers who made it to the Final Qualifying Stage must attend the photography session scheduled as follow;

First Qualifying Stage (Section A): 6 – 8 November 2023, from 8:00 AM – 4:00 PM (Thailand Time)

First Qualifying Stage (Section B)*: 13 – 15 November 2023, from 8:00 AM – 4:00 PM (Thailand Time)

Final Qualifying Stage: 25 - 27 December 2023, from 8:00 AM - 4:00 PM (Thailand Time), at the tournament office.

On the day of your photo session, you should dress in golfing attire and a golf hat. (T-shirts, shorts, jeans, corduroy pants, and sandals are not allowed).

(e) Distance Measuring Devices (Rangefinders): NOT allowed during the tournament proper.
